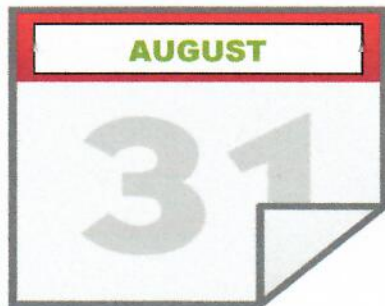

2018 NSP FUNDS

NSP FINAL PERFORMANCE REPORT (FPR)

2018 Final Reports are due to the Department of Community & Economic Development (DCED), no later than **Friday September 28, 2018**. As in past years, the FPR consist of a summary of your approved projects and expense detail, along with a detailed project report sheet that must be completed for each of your 2018 projects (additional sheets may be printed as needed). Lastly, please submit all receipts, copies of canceled checks or bank statements as verification for all expenses paid during the program year. Please note that to be eligible to participate in the 2019 NSP round, your completed FPR must be approved by DCED.

2019 NSP FUNDING UPDATE

Cincinnati City Council has allocated the Neighborhood Support Program \$340,429 for FY2019. That's a slight decrease from \$353,600 in FY2018.

As you may recall from the end of 2017, former Councilmember Kevin Flynn made a motion to repurpose \$30,000 from the NSP18 budget to pay for the cost of General Liability and Directors & Officers insurance coverage for all Community Councils participating in the NSP program. The aggregate insurance program has been received very well amongst Councils and resulted in increased savings for both them and the City. This year, DCED will again set aside \$30,000 from the overall NSP budget for Invest in Neighborhoods to purchase the aggregated insurance policy for a second year.

That leaves \$310,429 to be split amongst 51 eligible Community Councils – **or approximately \$6,085 per Council**. However, please be reminded that when you sign up with Invest in Neighborhoods for General Liability & Directors and Officers insurance coverage, there will be no cost to your Council. We feel strongly this is a net gain for all involved.
