**Board of Trustee Work Plan**. Identified 4 neighborhood priorities: Employment; Schools: Safety & Blight; and Balance Development.

**Officer Tim Eppstein** –Officer Eppstein will do a free safety assessment of your property. timothy.eppstein@cincinnati-oh.gov District is up 10% for violent crime but the city is down 3% on the 3-year average. Theft from autos is down by 28%. Homicides are up. Doing proactive work in area parks to reduce loitering and drug interactions.

**Don Mooney, of Save our Parks, regarding Issue 22, Park Tax,** - Tax Levy on the upcoming ballot. We love our parks, but the fine print in this proposal gives all the control of how the \$5,000,000 tax funding is allocated to the mayor instead of the Park Board or City Council. The proposal is not to fix or maintain what we have, but

to make changes without the input of the people. Many suggested changes are to reduce the green space and remove trees and lawns to enlarge the concrete space. Encourage you to go to the polls and vote no on Issue 22.

**Pam King, Citizen's Complaint Authority** – Formed in 2002 as a development of the collaborative agreement. The mission is to investigate interventions by Cincinnati Police Officers and to resolve citizen's complaints in fair, independent investigations. CCA has authority to investigate all ranks in the police department and are on call for any incident that involves a policeman firing a weapon. Directed by City Manager, Harry Black. <a href="www.Cincinnati-oh.gov">www.Cincinnati-oh.gov</a> CCA will present findings on 4 cases on Oct 5 at City Council. Pending is a liquor request by Circle A Market has applied for a liquor license to sell carry out beer and wine at his storefront in the New York Dry Cleaners building at 13th and Main. Motion to support the BOT letter by Bob Selhorst. Seconded by Julie Fay. Mr. Fade Isaac makes the liquor application. Residents can follow up personally to the city solicitor who makes the ultimate decision on whether or not to forward the application to the State of Ohio. Residents and businesses are encouraged to call City Solicitor Paula Boggs Muething at 352-3320 to object. Fade Isaac has a history of pandering to an undesired clientele that have caused people to stop living and/or stop doing business on Main Street. Motion passes unanimously.
