First, I am currently spearheading the OTR Housing Inventory Project on behalf of Over-the-Rhine Community Council and I'd like to see that project through to completion. There has been much debate and speculation in the media, city hall and behind closed doors about how much of our residential property is subsidized versus how much in market rate. I raised \$25,000 to hire Community Building Institute to do the research to answer that question. It may be September until the research is finished and the data is compiled. Then we'll know the answer. I'd like to continue as a board member to oversee the execution of these restricted funds and grants and the management of this project for the OTR Community Council.
Secondly, on behalf of OTR Community Council and with their support and direction, I have applied to Pro Bono Partners for professional legal oversight of our by-laws. I would like to continue as the liaison to make our by-laws efficient, inclusive and better to serve the membership as well as a wholly volunteer board of trustees.

For the past 32 years my professional life as a history teacher, coach, elementary and middle school principal, director and assistant superintendent has provided me with the experience and skills to serve as a member of the board of trustees. In those various roles I have taught and coached over a thousand students and I have helped to lead individual schools with staffs ranging from 60 to 100 employees to a district serving over 8000 students with 1000 full time and part-time employees. As a school administrator I was responsible for organizing curriculum, instruction, assessment at the building and district level and managing budgets, communicating with internal and external stakeholders, and developing training for bus drivers, custodians, teachers, and principals. As Assistant Superintendent of Oak Hills School District I have worked directly with a variety of community organizations ranging from police, fire, local governments, businesses, and non-profit groups to serve the children and families of our district. I also serve as an adjunct professor for Xavier University, Vice President of the Ohio Middle Level Association and on the Ohio Department of Education Schools To Watch Leadership Board. This experience has provided me with the community organization skills that can serve the residents of OTR.

Since 2009 I have been able to use my history teaching skills and serve as a volunteer tour guide for the OTR Brewery District and I also serve as history tour guide for Old St Mary's Church. These volunteer roles have enabled me to tell the amazing 200 year old history of OTR, one of the largest historic districts in the United States. This has given me detailed insight into the many historical assets in OTR. Three years ago my wife and I decided to sell our suburban house and use our life savings to rehab a 162 year-old OTR shell of a building and turn it into our home. As the general contractor on this project I gained firsthand skills and knowledge on the preservation and restoration of historic shells in OTR. This successful project encouraged my family to purchase another historic shell in OTR for development and preservation.

Collectively, this experience combined with a love and passion for improving the quality of life for all residents of OTR will enable me to bring a unique skill set to the board of trustees.

What are some things that you would like to work on and to see happen during your term as a trustee?

One of the more serious problems confronting many residents of OTR is unemployment and poverty. As a community council we have the potential to help bring together a variety of community assets and businesses to focus on employing local residents who are un/under employed and living in poverty. OTR Community Council can serve as an advocate and as an organizer of local businesses willing to employ and train low income residents. Imagine the long term benefits of finding and securing either part-time or full time employment for 100 young people and adults each year? In five years we could help to find jobs for 500 teenagers and adults. That would have a tremendous positive result on the quality of life in OTR. OTR consists of 362 acres and a population of roughly 8,000 people. We know that there is not enough tax money or resources from city, state, and federal government to resolve these serious community problems. But, combining these government resources with community resources and the power of people we can greatly improve the quality of life for all of our residents. In addition to organizing community assets to lower unemployment among low income families, I would like to help lead a detailed study of how we can organize OTR families and businesses to adopt sidewalks, streets, and alleys to form block watch teams to address crime. graffiti, trash, and possible serious building code violations that present safety concerns for residents. These resident block teams would help to improve their sidewalks, streets, and alleys. Involved citizens with a clearly defined mission and task can work together to improve the lives of all residents. With your support I hope to work with the OTR Community Council to identify partners and move forward.

Members may recall a sitting officer by a two-thirds majority vote, after due deliberation, at the next regular meeting.

Since 1984, I have been and continue to be instrumental in many facets of the on-going revitalization of the Klotter – Conroy neighborhood. Skills and knowledge gained as an OTR real estate developer and property manager will be used as the board weighs in on OTR development, as it pushes north of Liberty.

I have served as the volunteer leader of the Klotter – Conroy Residents Association since 1984. Core functions of the Association where I continue to play a leadership role are:

- 1. Establish and maintain e-mail communication among about 50 property owners and residents.
