 - a. District one-Sharp Alley project moving forward-goal is to alleviate crime. OTRCC asked that the Police report back after the 6 month mark of it closing on the outcome of the closure. Crime is trending down.
 - b. Fire Department-Engine 5- Capitan W. About 13 emergency runs a day out of that fire house. This house doing about a quarter of the cities narcan runs (last month's data).
 - c. Rothenberg-Principal Simpson-open house tomorrow from 3-5pm. Open to everyone! Talked about school's overall grade from the state. They are at a D, but have shown some improvement in some areas and have taken a deeper dive into the data. Fall festival will be October 31st-rotating stations and school parade, trunk or treat outside.
 - d. SCPA-Holly Brian's Ragusa-Discover SCPA day October 27th-open house to anyone to see the school. Upcoming show called "Labelist" will be part of the OTR Film Festival. Major musical will be *Little Shop* of Horrors in November.
 - e. Mike Bootes-Voter Registration –Ohio has purged its voting roles aggressively. Oct 9th is the last time to register if you have been purged (not voted in 2 years or moved). Our voter participation has been lower than 20%. Please encourage your friends and neighbors to check their registration.

 - b. Ryan O'Malley- 1518 Race St Project-they are in the process of making some changes after getting some feedback. Rick Powell is the developer and was here to introduce himself- he grew up in the Fay Apts on the west side-has experienced many different sides of the city. Doesn't want the building to be for a select wealthy few and wants the design to inspiring and life giving. The current zoning allows for a 6 unit building-this project asked for a variance to build a 15 unit building. Have removed 5th story from original design-4 story building now. They would want rents to be at \$1200 a month and say this would

be a on the more affordable end of the market. If they had to reduce the number of units to fewer than 15 they would have to raise the rents.

c. Anthony Cradle and Ryan Dyson. City of Cincinnati (DCED). Concerning RFPs. 2 new ones recently released. 1521 Vine and 1512-1521 Republic. Community Engagement forums scheduled for these RFPs-October 9th and 11th at 5:30 at the City (Centennial bldg.) They are looking for residential development (mixed income or affordable) to happen on these sites.
